District, Herein after referred to as the parties of the first part which terms shall mean and include all their heirs, successors-in-interest, assigns etc.

- B. And whereas the said lands were in possession of Bijja Sathayya and Bijja Yadaiah the parties of the Second Part herein above mentioned who were cultivating the same.
- C. And whereas vide proceedings dated 14.3.1986 bearing no. J/773/86, RDO the name of the original pattedar namely Late Shri. Bijja Maisaiah was deleted and in its place the name of parties of the Second Part was registered as pattedars vide further proceedings No. B/828/86, dated. 4.5.1988 and thereafter pattedar pass books and title deeds were issued in the name of parties of the second part by the Mandal Revenue Office, Keesara Mandal, R. R. District as per the details given below.

And whereas due to intervention of elders and well wishers an amicable settlement has arrived at in which the parties of the Second Part agreed to purchase rights claimed by the parties of the First Part in an unregistered agreement dated 5.3.2001, in respect of the land in Sy. No. 224 admeasuring Ac. 0-10 Gts., and Sy. No. 233 admeasuring Ac. 2-30 Gts., which is hereinafter referred to as schedule mentioned property.
- Whereas the parties of the First Part along with the other family members have received the compensation of Rs. 25,00,000/- (Rupees Twenty Five Lakhs Only) as per the terms of the unregistered agreement dated 5.3.2001.
- H. And whereas in view of compensation paid by the parties of the Second Part to the parties of the First Part in lieu of all the rights claimed by the parties of the first part in respect of the schedule mentioned property the parties of the first part had agreed to confirm the tile of the parties of the second part in respect of the schedule mentioned property and had agreed to execute appropriate deed confirming title of the parties of the Second Part.

NOW THEREFORE THIS AGREEMENT WITNESSETH AS UNDER:

- 1. The parties of the First Part hereby confirm that the parties of the Second Part alone are the owners of the schedule mentioned property being land admeasuring Ac. 0-10 Gts., in Sy. No. 224 and Ac. 2-30 Gts., in Sy. No. 233 situated at Nagaram Village, Keesara Mandal, R. R. District. The Parties of the first part or any other legal heirs of Bijja Maisaiah do not have any right, title or interest in respect of the same.
- 2. The other family members of the parties of the First Part i.e., Bijja Dasu Goud son Late Shri. Bijja Maisaiah, Shri. Bijja Raju Goud son. Dasu Goud, Bijja Anand Goud son of Dasu Gound, Bijja Vijay Goud Son of Dasu Goud, Bijja Anil Goud son of Dasu Goud had also confirmed the right, title and interest of the parties of the Second Part and their family members in respect of the said property while executing the said agreement dt. 5.3.2001.
- 3. The parties of the First Part along with their family members therefore hereby confirm and covenant that either the parties of the First Part or any other person claiming through them do not have any right, title, interest in respect of the schedule mentioned property and as such it is the parties of the second part alone who are the absolute owners of the same, entitled to enjoy the same without any let or hindrance.
- 4. The parties of the First Part hereby confirm that they shall sign, verify and execute such further documents as required so as to effectively transfer/mutate the schedule mentioned property in favour of the parties of the second part.
