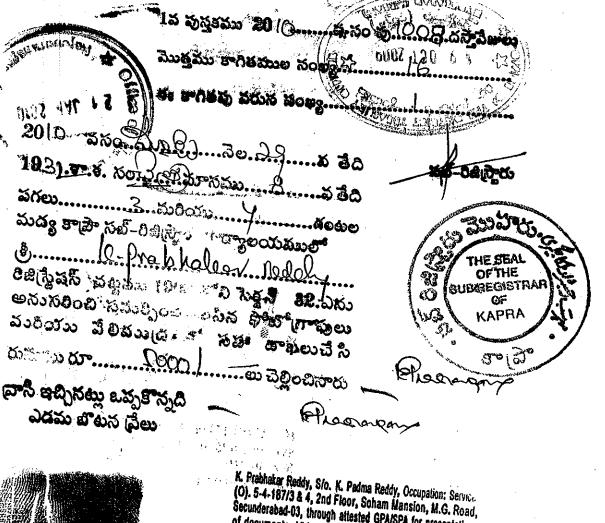

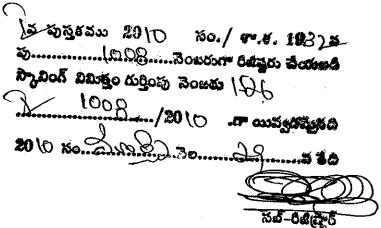

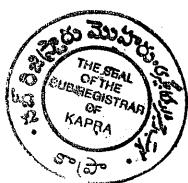

- d.
