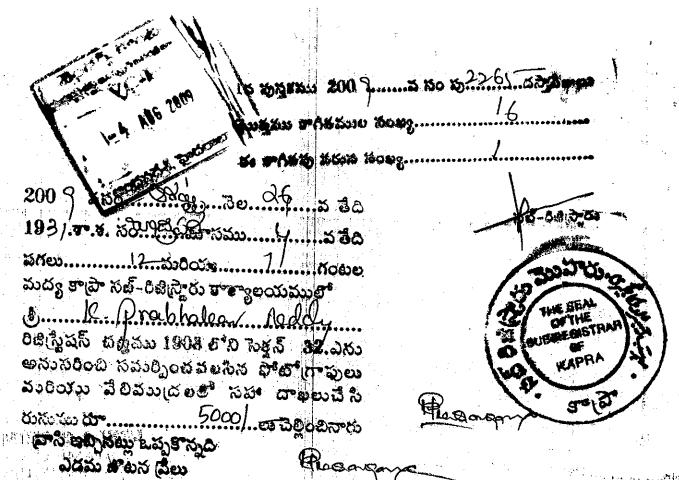

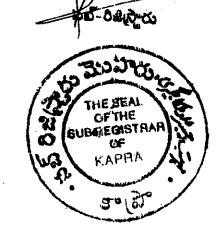
- c.
