## NOW THIS AGREEMENT FOR SALE WITNESSETH AS FOLLOWS:

- 1. That in consideration of Rs. 4,75,000/- (Rupees Four Lakhs and Seventy Five Thousand Only) the VENDOR hereby agrees to sell and VENDEE agrees to purchase the Schedule Property
- 2. That the VENDEE has paid a sum of Rs. 10,000/- (Rupees Ten Thousand Only) to the VENDOR by way of Earnest Money and part payment of sale consideration, the receipt of which is admitted and acknowledged by the VENDOR. The VENDEE further agrees to pay the balance of sale consideration of Rs.4,65,000/- (Rupees Four Lakhs and Sixty Five Thousand only) on or before 1st of April 1997.
