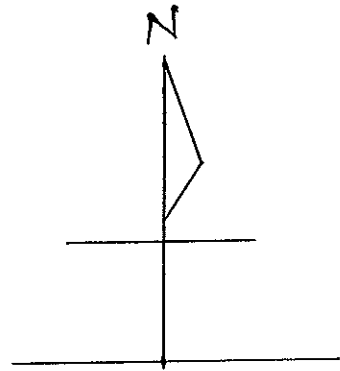
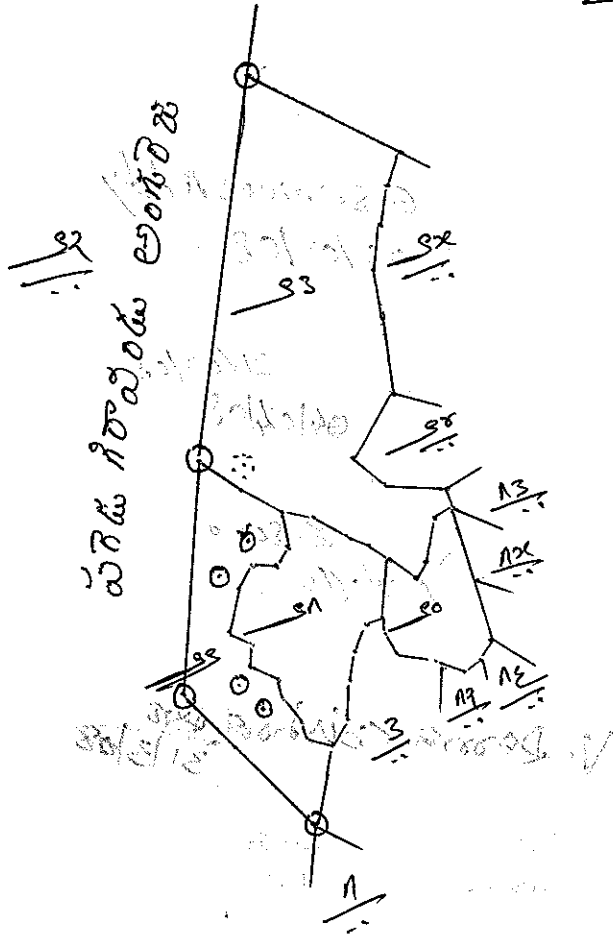

Death Certificate issued by the Alwal Municipality.


A notice has been published on 22-12-96 calling the
