
ORDER:

In the reference cited Sri Y.Srinivas Reddy S/o late Chandra Reddy R/o Kowkur village, Malkajgiri Mandal has submitted a petition stating that through the reference 1st cited the then Mandal Revenue Officer, Malkajgiri has granted the succession orders in favor of Sri Y.Srinivas Reddy, Sri Y.Raghupathi Reddy, Sri Y.Jagadishwar Reddy, Sri Y.Krishna Reddy and Sri Y.Ram Reddy and Sri Y.Balwanth Reddy all Sons of late Y.Chandra Reddy having equal shares of the following agricultural lands at Kowkur village of Malkajgiri Mandal.

The Village Assistant of Kowkur is hereby directed to incorporate the names of above persons as per the succession orders in the Pahani for the year 2001-2002. These orders are issued subject to the provisions of Urban Land Ceiling and Regulation Act 1976.
