Sub: Objection for Foot Over Bridge in front of St. George's Church,  
Hyderabad - Request - Regarding.

The undersigned would like to draw your attention to the fact that the foot over bridge proposed in front of St. George's Church, Abid Road, Hyderabad is not desirable and objectionable as we request you to kindly shift it some other place. But in your reference Proc.No. 68/AD3/Advt/GHMC/2005, dt: 13-06-2008, that the location is showing as Abids (Opp. Grammar School) with (2) Escalators and (2) lifts, but your project has started right in front of main gate of the St. George's Church. The reasons for objection are:

1. The primary reason is that the Church will be extremely Vulnerable for attacks and assaults by anti social groups as it will be open to public view very clearly.
2. There will be no sanctity to the Church and worshippers, especially when the prayers will be held in open areas during services, religious functions etc.
3. The Church will be exposed to the mischief-mongers who will be standing on the bridge and can create nuisance to the regular worshippers.
4. And also it is highly inconvenience and hindrance for the worshippers to enter the Church premises due to the pedestrian talking which can cause severe law order problems.




5. And the regular officials visitors are the dignitaries in police department, G.H.M.C., and other Government Officials, who will face security threat.
6. And the Church Building is 140 years old heritage building and effects the serenity of the environment.

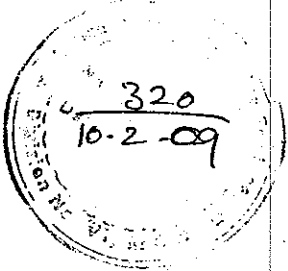

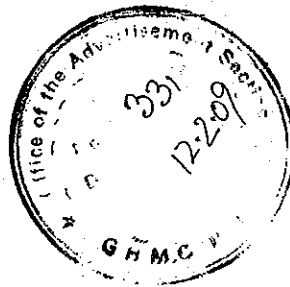

### ORDER

1. Sri. Soham Modi has filed an appeal dated 06-08-09 which was received on 17-08-09 by this Commission against the Public Information Officer and Appellate Authority for Non-furnishing of information to him.
2. According to the appellant he filed an application dated 26-05-2009 before the Public Information Officer, O/o. Greater Hyderabad Municipal Corporation, Tankbund, Municipal Complex, Hyderabad.
3. The appellant sought the following information from the Public Information Officer.  
*A) The High Court has directed GHMC to furnish the plan and details of Alignment and positing of the foot over bridge (FOB) going to erect before Methodist Complex, Abids*  
*Now he requests that plan copy etc. under RTI Act.*
4. The Public Information Officer did not furnish the information.
5. The appellant filed 1<sup>st</sup> appeal u/s. 19(1) before the Appellate Authority i.e. Addl. Commissioner, GHMC, Head Office, Hyderabad on 09-07-2009.
6. Having not received the information from PIO/Appellate Authority the appellant filed second appeal before this Commission under section 19(3) of RTI Act, 2005.
7. After examining the material papers available, the Commission ordered notices to the parties and posted the appeal for hearing on 16-10-2009.
8. On 16-10-2009 both the appellant and the respondent called present.
9. The Commission directed the respondent to furnish the information sought to the appellant and compliance to the Commission within seven days from the dated of receipt of this order.
10. With the above direction the case is disposed off.
