## IN THE HON.BLE COURT OF XI ADDL. CHIEF METROPOLITAN MAGISTRATE AT SECUNDERABAD.

Honoured Sir,

This is a case of criminal breach trust and cheating committed by the clerk (Accountant) of a business firm M/s Alpine Estates, 103, 1<sup>st</sup> floor, Hariganga complex, Ranigunj, Secunderabad to the tune of Rs. 30,000/- on 26.5.2009 which was falsely credited to a bank account of the contractor working for the business firm and fraudulently withdrawn by the accused Vasanti w/o Narendra Kumar aged 32 yrs who was working as Accountant and on pay rolls of the business firm M/s Alpine Estates.

The brief facts of the case are that on 7.8.09 at 12.30 hrs received a court referred complaint of L.W.1 representing M/s Alpine Estates, 103, 1st floor, Hariganga complex, Ranigunj, Secunderabad from the Hon.ble Court vide Dis.No. 1288/XI Addl.CMM/HYD/2009 dt. 22.7.2009 for investigation and report U/s 156 (3) Cr. P.C. The complaint was lodged against the accused Vasanthi w/o D. Narendra Kumar aged 32 yrs Occ: Accountant, M/s Alpine Estates, 103 1st floor, Hariganga complex, Ranigunj, Secunderabad r/o 20-36, G-1, Rohith Mansion, Malkajgiri, RR Dist. The complaint revealed that during the tenure in complainant firm, the accused has committed the following illegal transactions by way of misappropriation and cheating. Following are the details.

1. The accused has taken the signature of the managing partner on a cheques bearing no. 050386 dated 26-5-09 for Rs. 30,000/- drawn on HDFC Bank, Secunderabad purported to be towards the payment made to a supplier by M/s. Hemanth Marbles. On verification, it was found that the cheques were actually drawn in the name of one L.W.5 who has an account in HDFC Bank, Sainikpuri Branch. The said L.W.5 was in no way concerned with the transaction for which the cheques were supposed to have been given. Further the accused had drawn the amount from the account of Mr. Satyanarayana by using a ATM card to which the accused had access.

The accused raised a cash receipt bearing no. 2187 dated 11-3-2009 for Rs. 40,000/- for the cash that was received from Dr. H.S. Saini, a customer of the complainant firm and who has booked a flat in one of their ventures. On verification it was found that there has been no corresponding entry in the cash book nor the amount was reflected in the Bank Account as a deposit. The accused has obviously

misappropriated the funds.

The complainant submits the accused had further raised another cash receipt bearing no. 2159 dated 7-2-2009 for Rs. 2,00,000/- for the cash that was received from a client of the complainant firm by name Mr.s O. Shanti, and who had booked a flat in one of the ventures of the complainant firm. On verification it was found that there has been no corresponding entry in the cash book nor the amount was reflected in the Bank Account as a deposit. The accused has misappropriate the funds obviously.

The complainant submits that as the accused was totally incharge of the account records and she was also handling the cash receipt books. The complainant had a cash receipt book which had an original in white colour and duplicate copy in pink colour. In one of the receipt book bearing no. 10, the duplicate copies for two receipts bearing no. 1948 and 1949 have been torn and destroyed by the accused deliberately to surprise the fraud that she had done. The fraud she had done is one of the cash receipt had been issued to one Ms. Priya Vanadana a customer of the complainant firm for the amount of Rs. 75,000/- that was paid by the said Ms. Priya Vandana. The said amount was also not recorded in the cash book nor in the Bank Account. The amount that was collected under Receipt no. 1949 is still missing and

the complainant is putting all efforts to trace the payment that was received through the Receipt no. 1949. The complainant is further probing into the misdeeds committed by the accused and trying to trace further misappropriation if any by the accused. If any thing is traced the same will be intimated to the investigating officer.

The complainant firm had issued a show-cause notice which was sent to the accused address by registered post act due and the same was received by her but

there has been no valid explanation from the accused.

The above said acts of the accused clearly show her dishonest intention to cheat the complainant firm by misusing her position in the organization and her access to all the records and also the cash that was being received from the customers of the complainant firm. The accused has committed a criminal breach of trust which is a crime U/s 405 of IPC the accused also committed offences of cheating, misappropriation of funds.

It is therefore prayed that this Hon'ble Court may be pleased to punish the accused for the offences U/s. 405, 420 of IPC for criminal Breach of Trust, Cheating, Misappropriation of amounts to a tune of Rs. 3,45,000/- and pass such other order or orders as this Hon; ble Court may deems fit and proper tin the circumstances of

the case.

As per the above contents, L.W.7 registered a case in Cr. No. 291/2009 U/s a05, 420 IPC r/w 156 (3) Cr. P.C. and took up investigation.

During the course of investigation examined and recorded statements of L.W s 1 to 6. The following documentary evidence was furnished by L.W.1 in support of the complaint.

- 1. Bank cheques No.503836 dt. 25.3.2000 for Rs. 30,000/- pertaining to HDFC Bank, Paradise issued in favour of Satyanarayana by Alpine Estates. Deposited in HDFC Kapra branch, Sainikpuri on 26.5.2009. Xerox copy of the same.
- 2. Bank statement of Sri P.Satyanarayana issued by HDFC Bank showing the "Funds Transfer, Hyderabad vide cheques No. 503836 on same day on 26.5.2009. The banks statement also showed ATM withdrawal through ATM, Kapra, Sanikpur on 26.5.2009 on two occasions of Rs. 15,000/- per occasion. The balance available account was Rs. 2,980/-.

From the above statements and documentary evidence, the investigation could establish that the following transaction was fraudulently committed by the accused and misappropriated the same for her use. She stopped working for the firm when her frauds came into light.

As per the statements of the above mentioned witnesses, the following facts came to light.

The accused was appointed as senior accountant on 7-10-2005 for Atome Estates, 103, 1st floor, Hariganga complex, Ranigunj, Secunderabad to work for the project Alpine Estates taken up by Modi Projects. Accused was accountable for all books of accounts. Accused was also handling the bank accounts, cheques books. Accused is resident of 20-37, G-1, Goutham Nagarm, Malkajgiri, Hyderabad. Accused is married to Narendra Kumar. Accused is qualified B.Com candidate and well versed with accountal aspects. Accused is having one daughter. Her husband is working as mechanic in APSRTC. L.W.s 2 and 3 have checked the account books of Alpine Estates and noticed the following irregularities committed by the said Vasanthi, Senior Accountant. The company is having HDFC Bank account for Alpine projects.

The cheque bearing no. 050386 for Rs. 30,000/- drawn on HDFC Bank, Secunderabad was accounted to have been issued in favour M/s. Hemanth Marbles but the cheques was deposited by one L.W.5 into his account with HDFC Bank, Salnikpuri branch. This person has no business transactions with Alpine Estates though he was our supplying contractor and he do not owe him any amount. The amount was withdrawn by him using his ATM card. He is resident of Guddimalkapur and civil contractor. On enquiry with him it is revealed that he has received SMS alert from HDFC Bank regarding deposit of the amount into HDFC Bank and that it was withdrawn through ATM card. His account was opened by our firm and his ATM card was also available with us. Accused has misused his ATM card and PIN. His account has been misused by Vasanthi to withdraw the amount of Rs. 30,000/- and misappropriated it.

- Accused issued cash receipt bearing no. 2187 dt 11-3-2009 for Rs. 40,000/-purported to have been received by her from one customer by name Dr. H.S. Saini who has booked a flat in Alpine Estates. Vasanthi has received the cash but not accounted it in cash book nor reflected it in bank account of HDFC, Secunderabad as a deposit. Accused has misappropriated this cash receipted amount of Rs. 40,000/- and caused wrongful loss to the firm and wrongful gain to herself.
- Accused issued another cash receipt no. 2159 dt 7-2-2009 for Rs. 2 Lakhs which accused was received from customer Mrs. O. Shanthi who has booked a flat in Abine Estates. There was no accounting for this money and accused has misappropriated the same and caused wrongful loss to the firm and wrongful gain to herself.
- Accused also tampered the cash receipt book No. 10 where in the two duptate copies of two receipts bearing Nos. 1948 and 1949 have been torn and destroyed by Vasanthi. One receipt for Rs. 75,000/- was paid by one customer by name Mrs. Priya Vandana and it was also not recorded in cash book and not deposited in bank. The amount collected under receipt No. 19459 is still missing and we are unable to locate the person and amount who had paid it.

There was prima facie evidence against the accused in respect of money she has received from Dr. H.S.Saini, Mrs. O Shanti and Ms. Priya Vandana who are clients of the complainant firm having booked flats in the Project M/s Alpine Estates But, I W.1 could not produce these clients. As such evidence exists fully against the accused in respect of a single transaction as shown below.

"The accused has taken the signature of the managing partner on a cheques bearing no. 050386 dated 26-5-09 for Rs. 30,000/- drawn on HDFC Bank, Secunderabad purported to be towards the payment made to a supplier by M/s. Hemanth Marbles. On verification, it was found that the cheques was actually drawn in the name of one L.W.5 who has an account in HDFC Bank, Sainikpuri Branch. The said L.W.5 was in no way concerned with the transaction for which the cheques was supposed to have been given. Further the accused had drawn the amount from the account of L.W.5 by using a ATM card to which the accused had access. His account was opened by Complainant firm and his ATM card was also available with accountant. Accused has misused his ATM card and PIN. His account has been misused by Vasanthi to withdraw the amount of Rs. 30,000/- and misappropriated it."

There is valid evidence from the documents furnished by L.W.1 as well as oral evidence of L.W.s 1 to 6 examined in this case.

It is prayed that the accused person may be tried and punished as per law for offence punishable U/s 408 and 420 IPC. The accused is absconding. It is prayed that warrant may kindly be granted to produce the accused in this case before the Hor ble Court.
