- D. The parties hereto after discussions and negotiations have reached certain understandings, terms and conditions etc., for the completion of construction of the scheduled apartment and are desirous of recording the same into writing.

NOW THEREFORE THIS AGREEMENT FOR CONSTRUCTION WITNESSETH AS UNDER THAT:

- 1. The Builder shall complete the construction for the Buyer a semi-finished, deluxe apartment bearing flat no. 517 on the fifth floor in block no. 'A' admeasuring 1625 sft. of super built up area and undivided share of land to the extent of 81.25 sq. yds, and a reserved parking space for one car on the stilt floor bearing no. A-96, admeasuring about 100 sft. respectively as per the plans annexed hereto and the specifications given hereunder for an amount of Rs. 21,00,000/- (Rupees Twenty One Lakhs Only).
- 2. The Buyer already paid an amount of Rs. 20,00,000/-(Rupees Twenty Lakhs Only) before entering this agreement which is admitted and acknowledged by the builder.

- 4. The buyer shall be liable to pay the balance outstanding within 15 days of receiving an intimation from the Builder as to completion of the Scheduled Apartment, notwithstanding the installments and due dates mentioned above.


