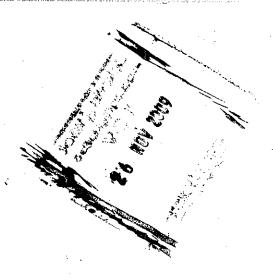

WHEREAS:
