ORDER:-

- The Government after careful examination of the proposals hereby allot U/s.23(4) of the Urban Land (Ceiling & Regulation) Act, 1976 the excess land as shown in columns 4 & 5 of annexure to this G.O. to the 3^{rd} parties in occupation whose names are shown in column 3 of the said annexure, as they have paid the amounts prescribed in terms of G.O.1st read above, the details of which are as indicated in columns 7 to 9 of the annexure.
- The name of the allottees (2 persons) shall be incorporated in Revenue, Registration & Survey records accordingly by the authorities concerned. The Chief Commissioner of Land Administration and the Commissioner & Inspector General of Registration & Stamps shall ensure compliance of these orders.
- 5. A copy of this order, together with the relevant sketch of the flat and the details of the un-divided share of land allotted, duly attested by the competent authority shall be delivered to the allottee concerned under proper acknowledgment.

6. The Special Officer & Competent Authority, Urban Land Ceiling, Hyderabad is requested to verify the genuineness of the primary documents relied upon with reference to the original records of the departments concerned and report the result to Government within a month positively.
