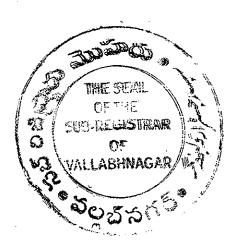

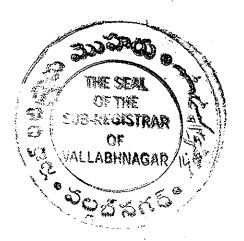

- K. The Buyer is desirous of purchasing a semi finished, semi-deluxe apartment bearing flat no. 323 on the third floor in block no. 'C' having a super built-up area of 1665 sft.
