With reference to your above referred letter please note the following:-

- a. Under clause 10.7 (c) of G.O. No. 86 M.A dated 03.03.2006 a through public access road of 9
  Mtrs on any one side at the periphery as per suitability and feasibility for access to the lands
  located in the interior is to be provided. Please find enclosed a revised plan with the suitable
  access road clearly shown. Care has been taken to ensure that the access road opens into
  vacant land located in the interior.
  - b. Nala position has also been clearly marked in the said site plan.
  - c. Although, we are not privy to the report of the engineer-in-chief, GHMC dated 02.12.2010 in file no. 461/TP-1/EZ/2010 we have marked the area affected under buffer zone in the revised site plan enclosed herein as per suggestion of the town planning department.
