Water, Land and Trees Rules, 2002, namely

1. Premises of felling tree/ trees is as mentioned as above only.
2. Number of tree / trees permitted to be felled is (5) Toddy Tree only ( Specify species and Number )
3. ( 50 ) No. of Plants shall be planted within ( 30 ) days of the felling.
4. In case of failure to take up plantation, plants shall be raised at the cost of the applicant.
