Registration Plan Showing The Plot No. 115.

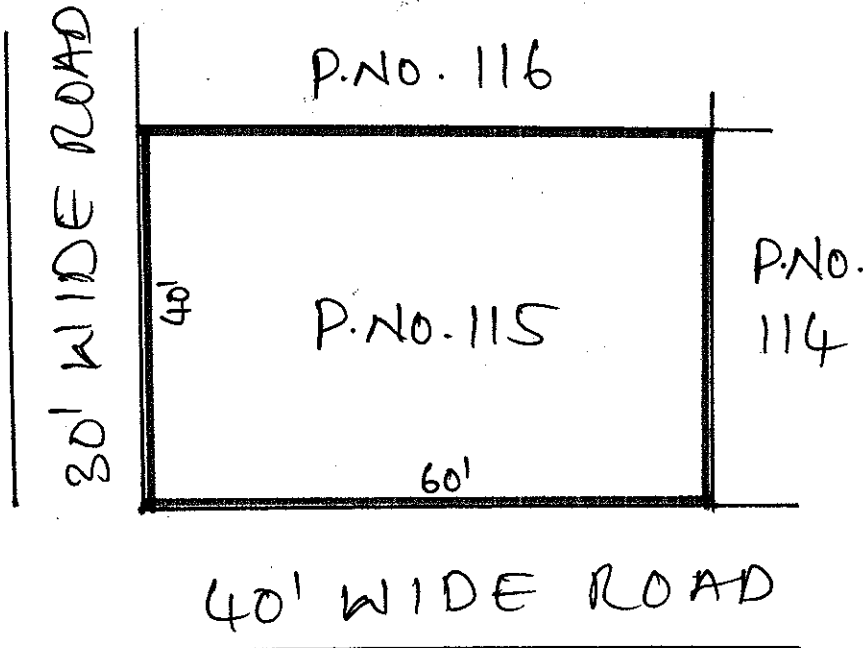
