BRIEF FACTS:

The Complainant Submits as follows:

- The Complainant is auBuildergand Developer and they have developed one such project under the name and style of "Silver Oak" Bungalows, Phase II, situated at Survey No.291, Cherlapalli, Hyderabad -500 051.
- The Accused Nos.1 and 2 have approached the Complainant for purchase of a Bungalow bearing No.231 in the above Venture and accordingly a Booking Form was signed by the Accused on 14.11.2006 and it was agreed for a total sale consideration of Rs, 48,85,228/- towards the cost of the plot of land and construction charges for the Bungalow. The above cost includes charges like registration, stamp duty, interest for delayed payment upto 18.3.2009 and other expenses. Accordingly, the Accused made an aggregate payment of Rs.36,88,499/- and towards balance amount including other charges the Accused No.1 issued a cheque bearing No.926568 dated 21.3,2009 for Rs.11,00,000/- drawn on Andhra Bank, Somajiguda Branch, Hyderabad.
- The Complainant presented the said cheque through their Bankers HDFC Bank, Lakdikapul Branch on 23.3.2009 for encashment. But to the utter shock and surprise of the Complainant, the said cheque has been returned with an endorsement "Insufficient Funds" vide Banker's Memo dated 23.3.2009. The Complainant informed about the dishonour of cheque and the Accused promised to pay the amount covered under the said cheque within a couple of days but they failed keep up their promise.

- 3. It is respectfully submitted that, thereafter the complainant through their Advocate, got issued a legal notice dated 2,4.2009 to the Accused demanding for payment of the said Cheque amount within 15 days from the date of receipt of the said notice and the said legal notice sent through Registered Post with acknowledgement due was served on the Accused but failed to comply with the notice.
- 4. It is respectfully submitted that issuing cheque without having sufficient funds in the bank account is an offence punishable under Section 138 of Negotiable Instruments Act, 1881 as amended by Act 55 of 2002. Therefore, the Accused is liable for her illegal acts and omissions which also amounts to an offence punishable U/S.420 of Indian Penal Code.
- 5. It is respectfully submitted that, by her illegal and malafide action, the Accused has rendered herself liable to be prosecuted for the Offence committed by him under Section 138 of N.I.Act, 1881 as amended by Act 55 of 2002.

6. CAUSE OF ACTION:

The cause of action for the complaint arose when the Accused issued cheque on 21.3.2009 towards balance payment of the cost of bungalows, on 23.3.2009 when the Complainant presented the cheque their Banker and on 23.3.2009 when the when the cheque is returned dishonoured for the reason of "Insufficient funds" by the Banker of Accused and on 2.4.2009 when the Complainant got issued a notice and on 4.4.2009 when the Accused received the said notice but failed to comply with the notice and the cause of action is still subsisting.

7. JURISDICTION:

This Hon'ble court has got jurisdiction to entertain this Complainant since the Complainant's registered office is situated at Soham Mansion.
