WHEREAS:

This Sale Deed was executed subject to the condition that the Buyer shall pay the development charges on land for the development of land by laying of roads, drainage lines, electrical lines, water lines, development of parks and other developments as per the rules of HUDA.
- The parties hereto after discussions and negotiations have reached into certain C) understandings, terms and conditions etc., for the payment of development charges and are desirous of recording the same into writing.

NOW THEREFORE THIS AGREEMENT WITNESSETH AS UNDER:

- The Buyer has agreed to pay a sum of Rs. 11,64,000/- (Rupees Eleven Lakhs Sixty Four Thousand Only) as the development charges to the Builder for development of the layout into plots by laying of roads, drainage lines, electrical lines, water lines etc., as per the rules of HUDA.
- The Buyer has already paid the said development charges an amount of 2. Rs. 11,64,000/-(Rupees Eleven Lakhs Sixty Four Thousand Only) which is admitted and acknowledged by the builder.
- The Buyer shall liable to pay the development charges on land irrespective of 3. the stage of development of the layout. The Buyer shall pay the amount as stated above and shall not raise any objection on this count.

- 6. Wherever the Buyer is a female, the expressions 'He, Him, Himself, His' occurring in this agreement in relation to the Buyer shall be read and construed as 'She, Her, Herself'. These expressions shall also be modified and read suitably wherever the Buyer is a Firm, Joint Stock Company or any Corporate Body.
 - 7. In the event of any changes in the terms and conditions contained herein, the same shall be reduced to writing and shall be signed by all the parties.






