



The Buyer shall not cut, maim, injure, tamper or damage any part of the structure of any part of the bungalow not shall the Buyer make any additions or alterations in the bungalow without the written permission of the Builder and / or any other body that may be formed for the purposes of maintenance of the Silver Oak Bungalows Project
