I invite kind attention to the reference cited and submit that there is no access at all to the applicants land i.e. Vista Homes except through Govt. Land in Sy.No.199 as the patta lands in Sy.No.193, 194 and 195 are surrounded by the Govt. land in Sy.No.199 and also reported that the applicants need 755 Sq.yards (170'x40') for access to their patta lands. The Government Land i.e. Sy.No.199 is recorded as Poramboke Sarkari. There is a existing road in the land in Sy.No.199 connecting to the existing notified slums i.e. Shubodaya Colony and Laxminarsimha Colony and leads to the HUDA layout colony i.e. Sri Vasavi Shiva Nagar Colony existing in the patta lands in Sy.No.178 and 179. 
