





- The Owners shall allow the Hirer to use the open land around the Villa and the 6. parking space attached to the villa without any charges.
- The Hirer shall maintain all other equipment's provided by the Owners to the 7. Leased Villa at their own cost.
- The Hirer shall not remove any of the Said Facilities provided by the Owners at 8. the Leased Villa and shall maintain the same in good and working order, normal wear and tear excepted.
- This General Amenities Agreement is co-terminus and co-extensive with the said 9. Lease Deed of even date executed in respect of Leased Villa. The parties shall not be entitled to terminate this General Amenities Agreement without at the first instance terminating the said Deed of Lease in respect of Leased Villa.
