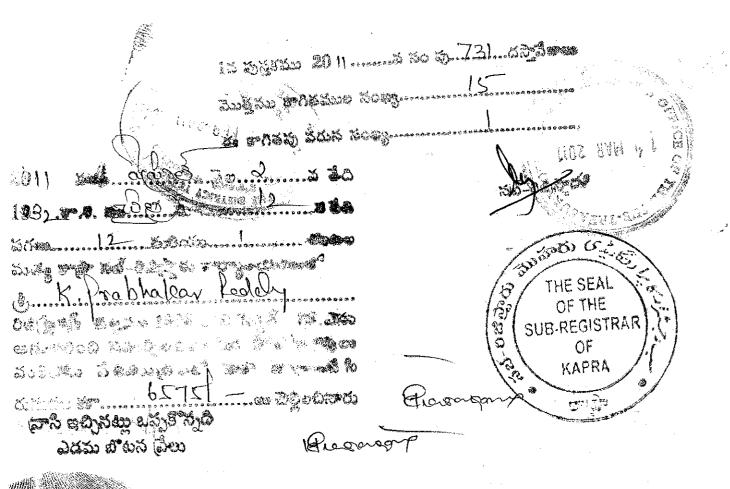

- F.
