Brief facts of the case are that on 7-8-2009 at xx.xx hrs. received a court referred complaint through the Honzble XI Addl. CMM Court, Secunderabad vide Dis.No. 1320/XI Addl.CMM/Hyd/2009, dt. 28.7.09 filed by the complainant Sri Soham Modi s/o Satish Modi, occ: Managing Partner, M/s Alpine Estates, 103, 1st Floor, Harignaga Complex, Ranigunj, Secunderabad against the accused Mr. M. Jagadish Babu, s/o MBBV Narsimha Rao, 46 yrs, occ: Pvt. Service r/o 63/2 RT, MCH Colony, Malakpet, Hyderabad in which the complainant states that, he is the Managing Partner of M/s Alpine Estates engaged in the business of development and construction of residential flats and independent houses. The accused Mr. M. Jagadish Babu was appointed as a Administrative Officer and assigned the duty of managing day to day administrative affairs at complainant; s construction site. He was appointed on 4-8-2007 and he was sole incharge of payment of miscellaneous bills like water bill, mid-day meals bill for school going children of site labour and other payments. The accused used to collect monies from the Head office to clear the billes at site. The accused also in-charge and responsible for all the material at the construction site of the complainant. On 31-5-09 the accused collected a sum of Rs. 7500/- for payment of water bill and to pay mid-day meals bill for school going children and he has not paid the same and utilized for his personal use. He also sold the scrap to Mr. Rehman, Scrap Vendor, Mallapur and received a sum of Rs. 19,500/- and he has not deposited the same at the head office and absented for duty from 15.6.09. Thus the accused with dishonest intention misappropriated the funds of the complainant also committed an offence of cheating, misusing his position in the organization committed offences of criminal breach
