Kadakia and Modi Housing. The term Builder shall mean and include both Modi Properties & Investments Pvt. Ltd. and Kadakia and Modi Housing.

TERMS AND CONDITIONS:

NATURE OF BOOKING:

- This is a provisional booking for a Bungalow mentioned overleaf in the project known as Bloomdale.
- 1.2 The provisional booking does not convey in favour of purchaser any right, title or interest of whatsoever nature unless and until required documents such as Sale Agreement / Sale Deed / Construction Contract, etc., are executed.
- 1.3 The purchaser shall execute the required documents within a period of 15 days from the date of booking along with payment of the 1st installment mentioned overleaf. In case, the purchaser fails to do so then this provisional booking shall stand cancelled and the builder shall be entitled to deduct cancellation charges as mentioned herein.

REGISTRATION & OTHER CHARGES:

- Registration Charges, Stamp Duty and incidental registration shall be extra and is to be borne by the purchaser.
- Service Tax & VAT as applicable from time to time shall be extra and are to be borne by the purchaser.

MODE OF PAYMENT: 3.

All payments from outstation locations are to be paid through DEMAND DRAFTS only. Demand Drafts Local Cheques are to be made payable to M/S. KADAKIA AND MODI HOUSING. - 6.2 In case of failure of the purchaser to obtain housing loan within 30 days of the provisional booking, the cancellation charges will be NIL provided necessary intimation to this effect is given to the builder in writing along with necessary proof of non-sanction of the loan. In case of such non intimation, the cancellation charges shall be Rs. 25,000/-.

- 6.3 In case of request for cancellation in writing within 60 days of this provisional booking, the cancellation charges shall be 50,000/-.
