No.14612/2006, Dt.06.10.2006. Subsequently, Issar Biotech has executed sale deed in favour of present applicant M/s. GV Research Canters Pvt., Limited in respect of Plot No.3 in Sy.No.542 admeasuring

Therefore, the grant of Grant of NOC for petroleum Class B HSD underground storage at M/s GV Research Centers Pvt Limited, Situated at Sy No 542, Plot No 3 Kolthur Village, MC Pally Mandal, Medchal Malkajgiri District may be considered as per Rules in force as recommended by the Revenue Divisional Officer, Keesara Division.
