WHEREAS:

- A) The Buyer has entered into an Agreement of Sale dated 27th December 2006 for purchase of a bungalow along with an identifiable plot of land (plot no. 207) in the project known as Silver Oak Bungalows (Phase-II), situated at Sy. - 1. The Buyer has agreed to pay in advance a sum of Rs. 12,08,000/- (Rupees Twelve Lakhs Eight Thousand Only) as the development charges to the Builder for development of the layout into plots by laying of roads, drainage lines, electrical lines, water lines etc., as per the rules of HUDA.
- 2. The Buyer shall pay to the Builder the above said development charges of Rs. 12,08,000/- (Rupees Twelve Lakhs Eight Thousand Only) in the following manner:

- 4. That the Buyer shall be liable to pay simple interest calculated @ 1.5% per month on all delayed payments of installments. Under no circumstances shall the Buyer delay the payment of installments for more than 3 months from the due date.
