NOW THEREFORE THIS AGREEMENT FOR DEVELOPMENT CHARGES WITNESSETH AS UNDER:

- 1. The Buyer has agreed to pay in advance a sum of Rs. 14,64,500/(Rupees Fourteen Lakhs Sixty Four Thousand and Five Hundred Only) as the
 development charges to the Builder for development of the layout into plots by
 laying of roads, drainage lines, electrical lines, water lines etc., as per the rules of
 HUDA.
- 2. The Buyer shall pay to the Builder the balance development charges of Rs. 14,64,500/- (Rupees Fourteen Lakhs Sixty Four Thousand Only) in the following manner:
