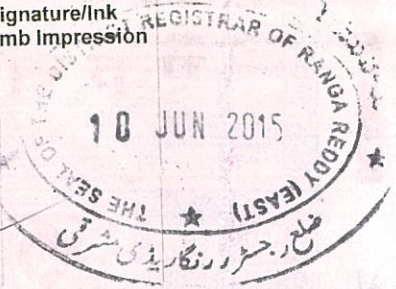

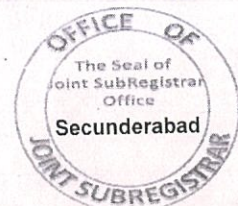

A. WHEREAS by a Deed of Sale dated 12th day of September 1983, executed between the Vendor and the Buyer, who are also the parties to this Rectification Deed, registered as document no.405 of 1983, at the Sub-Registrar, Secunderabad (hereinafter referred to as the Principal Deed). South : By Common Passage

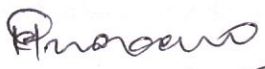
East : Shop No.7

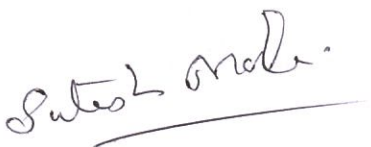
