- A. WHEREAS by a Sale Deed dated 30th day of July 1986, executed between the Vendor and the Buyer, who are also the parties to this Rectification Deed, registered as document no. 496 of 1990, at the Sub-Registrar, Secunderabad (hereinafter referred to as the Principal Deed). By way of the Principal Deed, the Vendor sold and the Buyer purchased office space bearing no.C-2, admeasuring about 1430 sft, on the third floor, in the building known as S. M. Modi Commercial Complex, bearing municipal no.5-4-187/5, situated at Karbala Maidan, Ranigunj, Secunderbad.
- B. Whereas in the Principal Deed in page no. 9, i.e., Annexure–1A, it is clearly mentioned that the undivided share of land pertaining to the office space sold by the Vendor to the Buyer, referred to above, is 31.77 sq.yds out of the land on which S. M. Modi Commercial Complex has been constructed.
- C. Whereas in the said Principal Deed inadvertently the following clerical mistake was made:

In page no.7, i.e., in the 'Scheduled of the Property Hereby Conveyed' undivided share of land was not mentioned.

D. WHEREAS the Buyer has requested the Vendor to rectify the said clerical mistake by means of this Rectification Deed.

NOW THEREFORE THIS RECTIFICATION DEED WITNESSES AS FOLLOWS:

1. The 'Schedule of the Property Hereby Conveyed' on page no. 7 of the Principal Deed shall hereafter be so read and construed as follows:

"C-2 office admeasuring to 1,430 sq. feet, along with 31.77 sq. yds, undivided share of land, being the portion of the building known as S.M. Modi Comnercial Complex bearing municipal no. 5-4-187/5, situated at Karbala Maidan, Ranigunj, Secunderbad, A.P.

North: Indian Iron & Steel Corporation

South: Private Common Road : Hussain Sagar Ring Road West : Neighbour's Building"

- 2. This Rectification Deed is hereby executed and limited to the above mentioned correction.
- 3. The Vendor has not received any fresh consideration for the execution and registration of this Rectification Deed.
- 4. Except the above said correction there is no change in the Principal Deed such as, building name, office / shop no., municipal no., floor, extent, location, etc. This document is therefore hereby executed without consideration to rectify the above said clerical mistake in the Principal Deed.
- 5. This Deed of Rectification deed shall read along with the Principal Deed and shall deemed to have come into force from the date of execution of the Principal Deed.






