

RECTIFICATION DEED (BY SELF DECLARATION)


This Deed of Rectification Deed is made and executed on the 18th day of August 2015 at SRO, Seucnderabad by:

- A. WHEREAS by a Deed of Sale dated 12th day of September 1983, executed between the Vendor and the Buyer, who are also the parties to this Rectification Deed, registered as document no.405 of 1983, at the Sub-Registrar, Secunderabad (hereinafter referred to as the Principal Deed). By way of the Principal Deed, the Vendor sold and the Buyer purchased shops bearing no.8 & 9, admeasuring about 739.5 sft on the ground floor, in the building known as S. M. Modi Commercial Complex, bearing municipal no.5-4-187/5, situated at Karbala Majdan, Raniguni, Secunderbad,


