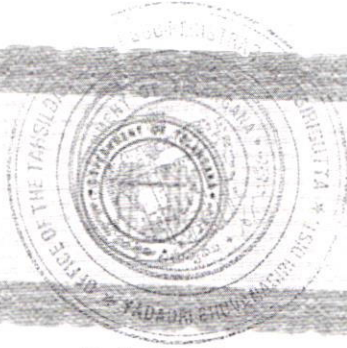

1908.

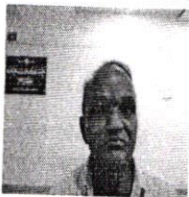
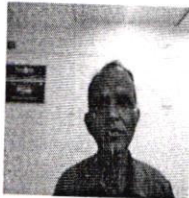
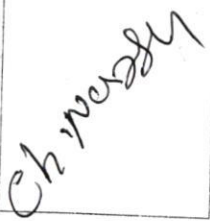
