When you think of Bhongir, you might think of the very famous Bhongir fort. But as a developing residential area, Bhongir might not promise more fort-like houses but can give similar peace of tranquility like living in a fort. Formerly known as Bhuvanagiri, Bhongir is located on National Highway 163 – the Secunderabad-Warangal route and the Secunderabad-Bhongir MEMU (Mainline Electric Multiple Unit) connect it to the main city of Hyderabad. The locality comes under the Hyderabad Metropolitan Development Authority (HMDA). "Grocery stores, supermarkets like Apna Bazaar, health care centres and pharmacies; ATMs, gyms, etc have fulfilled the need for basic facilities here. Veerabhadra Shopping Mall and SRS Complex are some of the nearby entertainment centres," says Shinde Amba Das, a real estate agent in Bhongir.
