Subject: Excess ITC - Certain clarification called for-reg.

With reference to above subject, please refer to your letter dated 23.12.2019, submitted this office on 03.02.2020.

After perusal of your reply, following information appears to be not found: -

1. In respect of the ITC of Rs. 6,19,025/- in F.Y. 2017-18 and Rs. 9,52,483/- in the F.Y. 2018-19 the details of invoices like Invoice no, date.

2. In the absence of such data it cannot be decided whether the payment of taxable value and tax is paid before 180 days in terms of proviso to section 16{2(d)} of CGST Act, 2017.

In the light of the above, the debit particulars of respective vendors in bank statement, if not produced shall be construed as not paid. Hence you are liable to reverse the said above said amounts immediately along with interest, as applicable.

Further, a difference was also found i.r.o ITC for the year 2018-19, is
