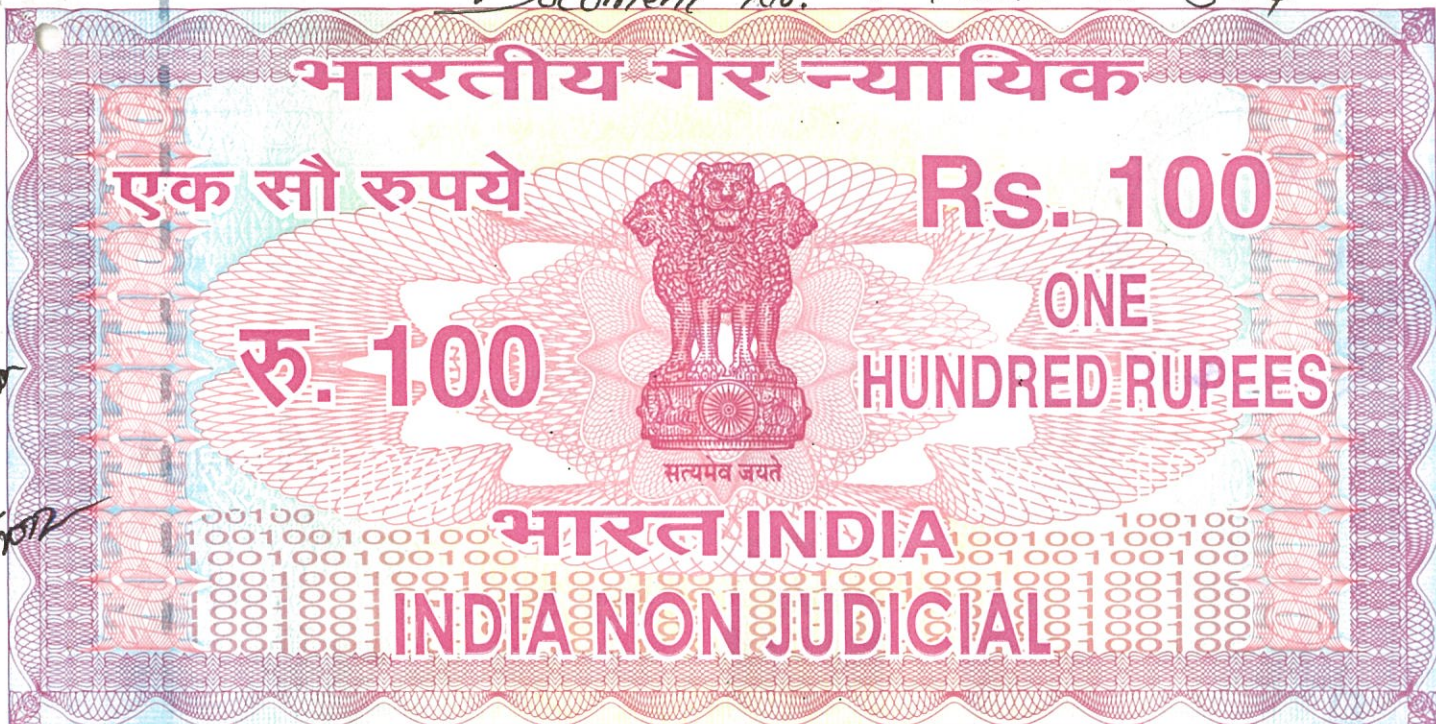

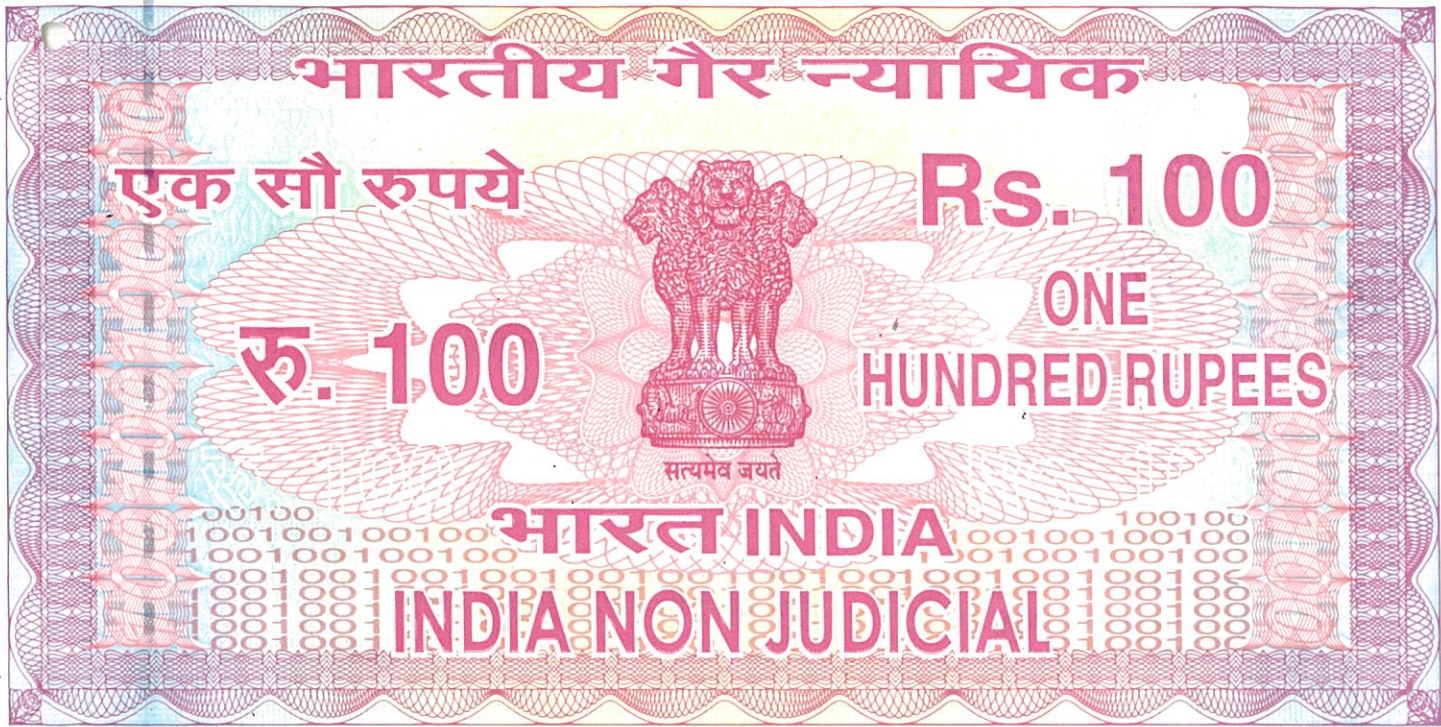

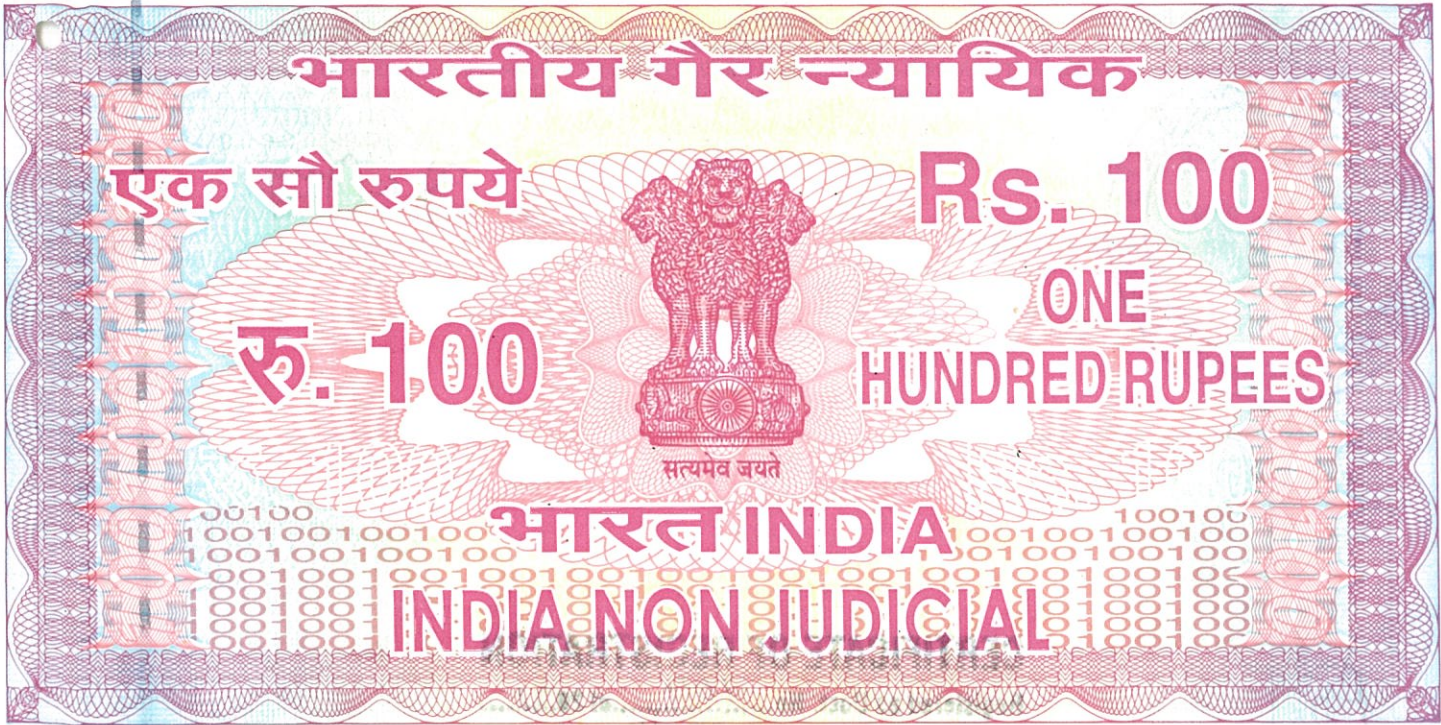

NOW BY THIS DEED, A TRUST IS HEREBY ESTABLISHED SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS WITNESSETH AS FOLLOWS:

I DECLARATION OF THE TRUST:

- This Trust shall be known as **MANILAL MODI CHARITABLE FOUNDATION** (hereinafter referred to as the "Trust"). This Trust shall be apolitical and autonomous Public Charitable Trust and the benefits of the Trust shall ensure to the Public without any sort of discrimination based on caste, creed, religious belief etc.
- The address of the trust for all the purposes shall be H. No 5-4-187/5/16/5, 2nd Floor, P. M. Modi Commercial Complex, Karbala Maidan, Secunderabad - 500 003. This may be changed according to the exigencies as the Trustees may deem it necessary.
- This Trust created by the Settlor is irrevocable.

There are no movable or immovable properties in the name of the Trust (except the corpus fund) as on the date of execution of this trust deed.

II TRUST FUNDS/PROPERTY AND ITS APPLICATION:

Trust Funds/Property includes the initial corpus amount of Rs.1,11,000/- (Rupees One Lakh and Eleven Thousand only) as stated above, all additions and accretions thereto, all contributions, donations and gifts that may be received, all the incomes generated there from, and all other properties that may be acquired out of the same will become property of the Trust.

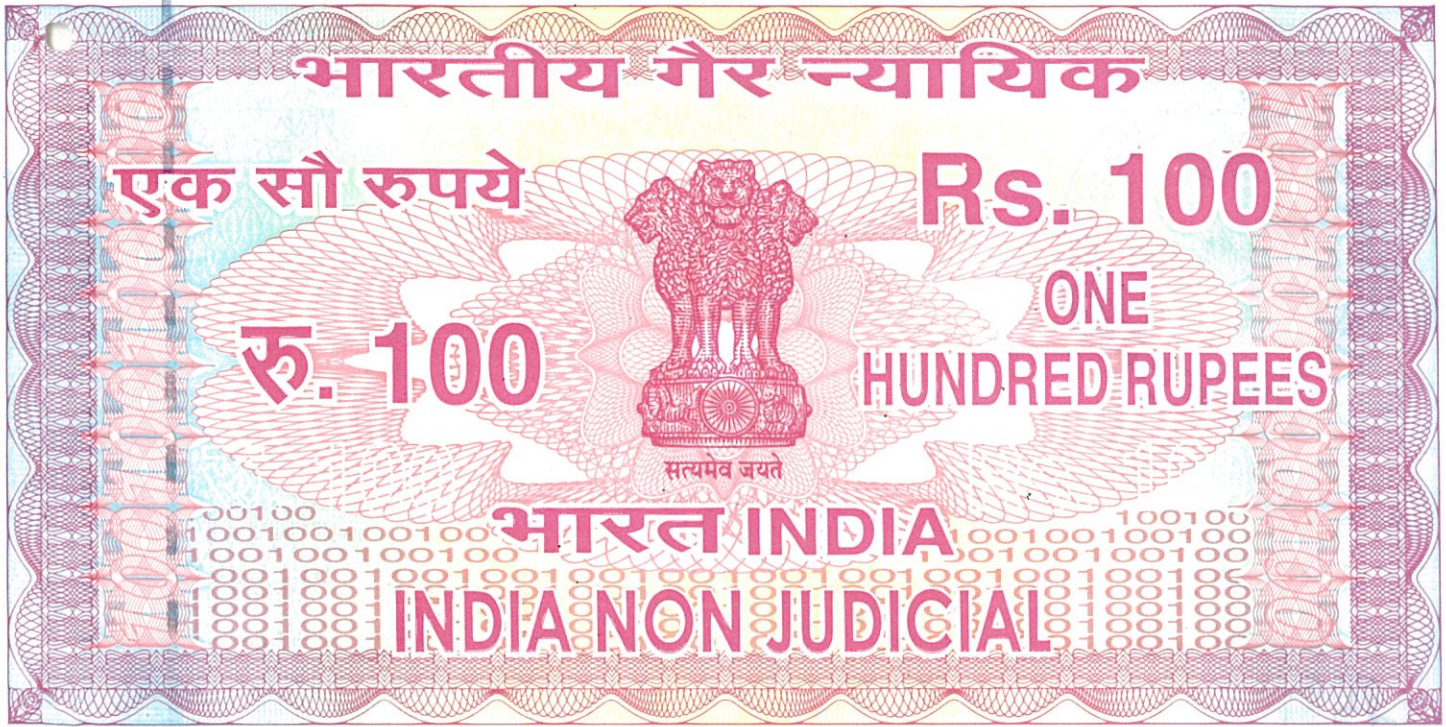

III AIMS AND OBJECTS:

The objective of creating this trust is to carry out Charitable Activities in order to provide medical relief to the poor and needy people of the Society. To provide other relief to the poor and carrying out activities for spreading Education. The main objects of the Trust are specified as under:

i) MEDICAL ASSISTANCE:

- To render help and assistance to needy and deserving persons in the form of subsidizing the cost for medical treatment and for maintaining good health.
- Rendering financial assistance to hospitals, clinics, health care center by way of donations for treatment of the poor and needy persons.
- To build or assist in building, take possession, alter and improve, maintain and operate medical institutions, research centers, clinics, nursing homes, maternity homes, sanatoriums, dispensaries and other facilities for rendering medical and health care to general public.

ii) EDUCATION:

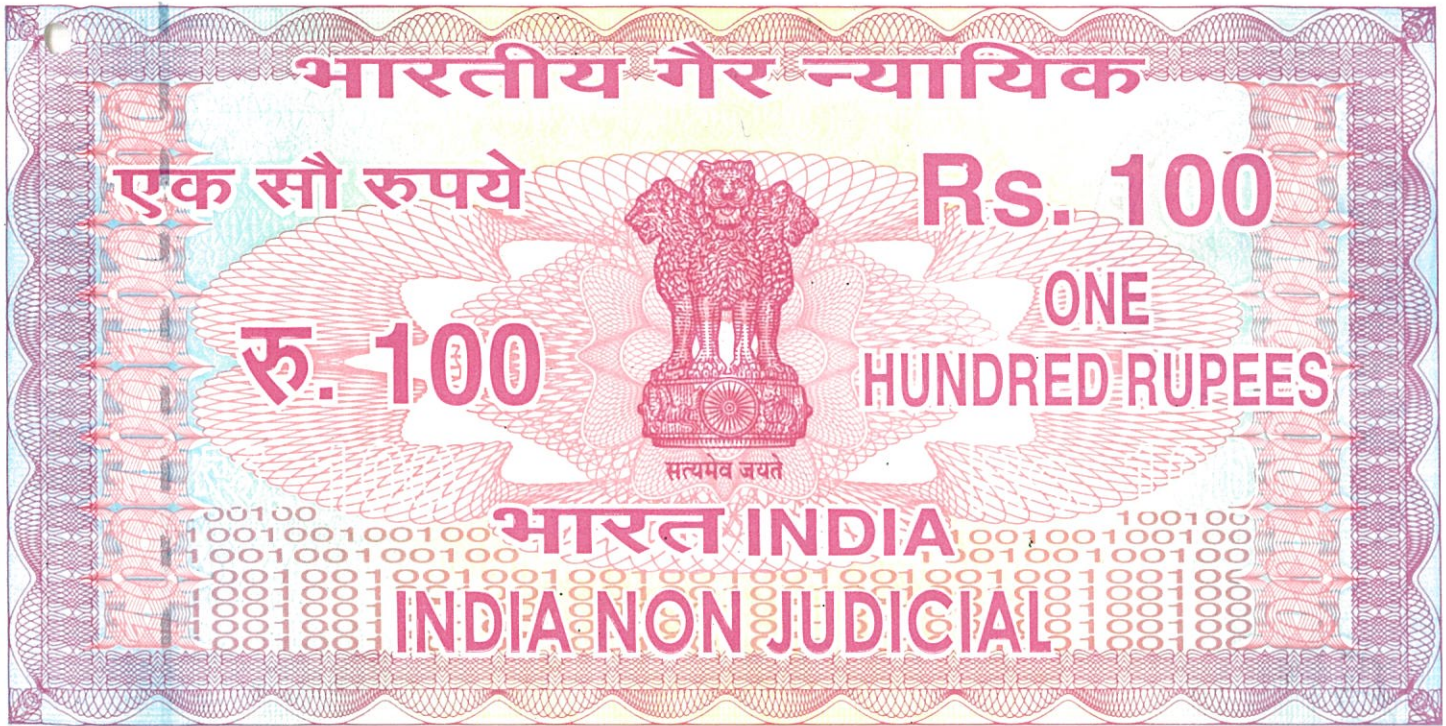
- To spread Education, organize lectures or seminars or make publications of books, literature, etc.
- Opening, maintaining schools, Colleges, libraries, Hostels, and Other educational and / or skill development institutions.

- c) Rendering help in the form of Scholarships to poor and deserving students, Rewarding to meritorious students.
- d) Rendering financial assistance to educational institutions, school, colleges, libraries and universities, by way of donations or subscription.
- e) To build or assist in building, take possession, alter and improve, maintain and operate hostels for boarding and lodging of needy and deserving students.

iii) RELIEF TO POOR:

- a) To provide food to the poor and needy persons.
- b) To provide clothes to the poor and needy persons.
- c) To provide help (monetary or in kind i.e. providing essential items) to the poor people.

ANCILLARY OBJECTS:

- a) The Trustees may utilize the income of the Trust for any other purpose not falling under any of the foregoing purposes provided it is beneficial to the general public and comes within the purview of the "Charitable Activities" as defined u/s 2(15) of the Income Tax, Act, 1961 as amended from time to time.
- b) To do all other things that helps in the attainment of the objects of the Trust.
- c) Physical Needs:
 - a. To give aid to deserving or poor needy persons in the form of money, clothes articles or providing them with shelter.
 - b. To give relief to people in distress caused by elements of nature such as famine, tempest, floods, earthquake or any other natural calamity.
- d) To construct, manage and run the Home for the aged persons, widows, destitutes, orphans, handicapped or poor, and persons in need and provide them with facilities, medical support and other needful things to take care, and do the things for their relief and upliftment.

IV BOARD OF TRUSTEES:

All funds, properties rights, claims, demands of every description belonging to or pertaining to the trust now or as may hereinafter be acquired from time to time shall vest in the Trustees for the time being who shall comprise the Board of Trustees.

The Administration of the trust shall vest in the Board of Trustees.

i) There shall not be at any time less than THREE including founding trustees.

ii) The First Trustees are:

- a) Shri. Kiran C. Mody S/o. Late. Shri. Chimanlal Mody
- b) Shri Ajay P. Modi S/o Late. Shri. Pravin Chandra Modi
- c) Shri. Soham Satish Modi S/o Late. Shri. Satish Modi
- d) Shri. Nirav P. Modi S/o. Late. Shri. Pramod Modi

The above Trustees shall be called Founding Trustees and shall be Permanent Trustees.

iii) The Trustees may elect any one of the Trustees as Chairman/Managing Trustee of the Trust who shall look after the day-to-day affairs of the Trust and shall exercise the powers conferred upon him/her by the trustees in their meeting from time to time. However, during his life time Shri. Kiran C Mody shall be the Chairman and shall be succeeded by Shri. Nirav P. Modi as Chairman during his life time. They shall enjoy veto power as Chairman on any subject notwithstanding any restriction otherwise, which power shall cease upon their demitting the position for any reason.

iv) The Trustees hereto shall have the power to co-opt other Trustees (Co-trustee) or remove any of the Trustees by a resolution passed at the meeting of the trustees, so however that their number inclusive of the Founding Trustees shall not exceed such numbers as may be decided by the Board from time to time by way of special resolution. Such co-opted Trustees shall have tenure of three years and shall automatically retire upon completion of three years as a trustee. However they could continue for two more such tenures of three years each upon being co-opted. However, an un-discharged insolvent, a minor, a person of unsound mind or a person who has committed any moral offence shall not be co-opted as a Trustee. The decision to co-opt or remove a Trustee shall be taken at a special meeting of the Trustees and decided on the basis of simple majority among the Trustees.

V CESSATION OF MEMBERSHIP OF BOARD OF TRUSTEE :

A Trustee shall cease to hold office in case of any of the following eventualities viz.

- a) Resignation by giving one month notice to the Board of Trustees.
- b) Due to death, insanity, insolvency, conviction for any offence involving moral turpitude or absence for more than Twelve Months without leave of absence granted.
- c) Co - opted trustees shall cease to be a trustees upon expiry of 3years form the date of co - option, incase, he/she is not co - opted for a further term.

VI MEETING OF THE BOARD:

- a. The trustees shall conduct at least two meetings in every year, 1 particularly after the finalization of the accounts which shall be done before 31 July each year. More meetings may be conducted as and when required.
- b. The meeting shall be presided over by the Chairman. In case, the appointed Chairman is not present, the Trustees present at the meeting shall elect one of the Trustees as the Chairman for meeting. No meeting of the trustees shall be held unless at least one-third of the trustees at the time or two of the trustees(whichever is greater) are present. The trustees may unanimously make regulations specifying different Quorum for any particular meeting. The decisions wherever possible shall be taken unanimously or otherwise by simple majority of the members present and voting and incase of equality of number of votes on a resolution, Chairman shall have deciding vote.

- c. A resolution, in writing circulated amongst all the trustees shall be as valid and effective as if it had been passed at a meeting of trustees duly called convened provided it is approved by majority of the Trustees.
- d. Notice of the meeting of the trustees and all communications may be sent to the trustees at their address registered for the time being in the records of the Trust/ on the Email ID of the Trustees registered in the records of the trust.
- e. A Trustee who is unable to be present at a meeting of the trust may send his view on the agenda in writing and such expression of opinion, shall be taken to be his vote on the matter concerned.
- f. The minutes of the proceeding of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting.

VII DUTIES OF THE TRUSTEES

- (i) The Trustees shall hold and use the trust funds/properties for the objects and purposes expressed herein.
- (ii) The Trustees shall do all such activities as would be necessary for attaining the objects of the trust.
- (iii) The Trustees shall maintain the correct statement of affairs (accounts) of the Trust and should get them Audited by Chartered Accountant.
- (iv) The Trustees shall ensure that the income of the trust that is accumulated for being utilized in subsequent year is kept invested/deposited as per the provisions of section 11(5) of the Income Tax Act, 1961.
- (v) Trust property, income, trustee position shall not be used by the trustees for personal benefit, profit motives.

VIII POWERS OF BOARD OF TRUSTEES:

All funds properties, rights, claims demands of every description belonging to or pertaining to the trust now or as may be hereinafter be acquired from time to time shall vest in the Board of trustees and they shall have all necessary powers for effective and prudent management.

Without prejudice to the general powers vested in the trustees by these presents or conferred by law or implied or vested in Board, the Board shall, for the purpose of carrying out activities for achieving objects of the trust and to manage and administer the trust Funds have the following powers enumerated herein, which shall be exercised by the Board of trustees strictly in conformity with the provisions of Income Tax Act, 1961 as amended from time to time so as to enable the trust to be exempted from Income Tax or other applicable laws:

- a. To acquire by purchase, gift, exchange, build, lease, hire or otherwise properties of all kinds including movable and/or immovable properties and to improve and add to the corpus of the trust.
- b. To purchase or otherwise acquire stocks, debentures annuities, and securities of every description.
- c. To sell, mortgage, lease out or give on license or otherwise alienate all or any of the properties of the Trust at such time for such consideration and terms that the Trustees may deem fit.
- d. To invest the monies of the Trust in such manner as the Trustees deem fit in their absolute discretion, and it is hereby expressly provided that it shall be obligatory upon them to invest the same only in the securities referred to in Section 20 of the India Trusts Act, 1882 or such other applicable acts and/or other securities approved by the Income Tax Authorities or any other Government body.

X ACCOUNTS AND AUDIT:

The Trustees shall maintain true and correct account of the receipts, payments, income, expenses, funds and properties of the Trust. Financial statements of the Trust shall be prepared every year as on 31st March. The accounts shall be audited by a Chartered Accountant. The audited accounts of the Trust shall be conclusive and be binding on the Trustees.

XI NO BENEFIT TO SETTLOR, TRUSTEES AND CONNECTED PERSONS

The Trustees shall not be entitled to any remuneration save right to reimbursement of expenses incurred in the discharge of their duties. Neither the Settlor, trustees nor their families, nor any of their relative or concerns in which any of these persons are interested will be entitled to any benefit prohibited by section 13 or otherwise directly or indirectly from the trust.

XII WINDING UP OF THE TRUST:

It is hereby declared and agreed that if at any time the Trust herein shall be rendered impossible of being acted upon and executed, it shall be lawful for the Trustees to dispose-off and transfer the Trust property together with all accumulated income, if any, to such institution or institutions (with same or similar aims and objects and which has been registered u/s 12A of the Income Tax Act, 1961), as the majority of Trustees may think fit in accordance with the provisions of Income Tax Act, which is recognized by Commissioner of Income Tax.

XIII AMENDMENT:

Notwithstanding anything contained in this deed, No amendment to add, alter, change or delete any clause of the Trust Deed be made without written consent of majority of Trustees and no change of any kind in the object clause should be made without the prior approval of the Commissioner of Income Tax (Exemption) or any other Income Tax Authority who has jurisdiction over Trust.

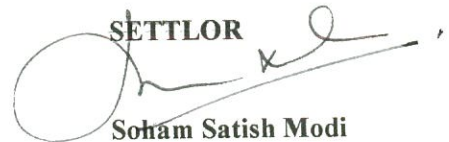

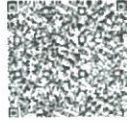

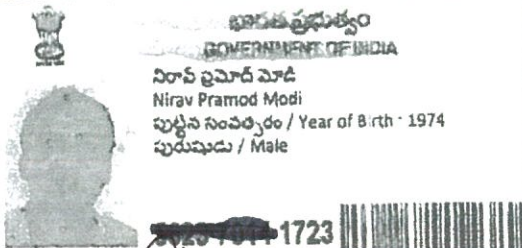
