Subject: Novation of rights pertaining to common area maintenance from Rx Propellant Private Limited (hereinafter referred to as 'RX') to JVRX.


Dear All,

With effect from 18 April 2022, all rights and obligations of RX in respect of CAM stand novated to JVRX and JVRX shall be entitled to receive a facility management fee of INR 1/- per sft per month towards the common area maintenance.
