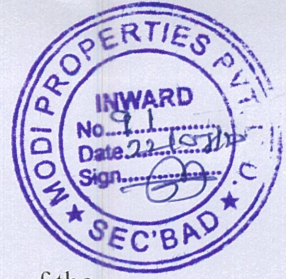

Please take notice that M/s. Modi and Modi Constructions, Secunderabad have preferred
an appeal before the Addl. Commissioner (ST) against the Final Assessment Order passed by the
Dy. Commercial Tax Officer, M.G.Road Circle vide AO No.47202, Dt.09.12.2019 under VAT
Act for the period January 2014 to June 2017 and the disputed tax is Rs. 14,18,019/-. The Addl.
Commissioner (ST) has gone through the case and the issue involved there in has granted stay of
50% of total disputed tax i.e., Rs.14,18,019/- on a condition that the appellant petitioner shall pay
50% of disputed tax i.e., Rs. 7,09,010/- within (15) days from the date of receipt of this order.
You are hereby instructed to pay the arrears within the stipulated time.
