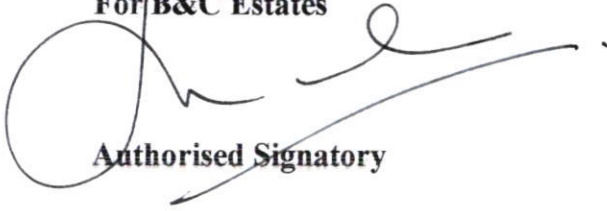

Kindly do the needful and acknowledge this letter.

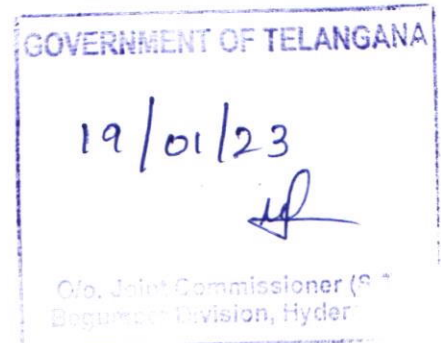
