For the period April 2013 to May 2014 the demand as per assessment order was Rs. 8,78,505/- of which an amount of Rs. 4,39,253/- was paid as pre-deposit. Accordingly, balance amount payable is Rs. 4,39,252/-. After 50% waiver the balance amount payable is Rs. 2,19,626/-.

For the period April 2013 to May 2014 the demand as per assessment order was Rs. 2,19,626/- of which an amount of Rs. 27,453/- was paid as pre-deposit. Accordingly, balance amount payable is Rs. 1,92,173/-. After 50% waiver the balance amount payable is Rs. 96,087/-.
