TAX SECUNDERABAD GST VS. MEHTA AND MODI HOMES

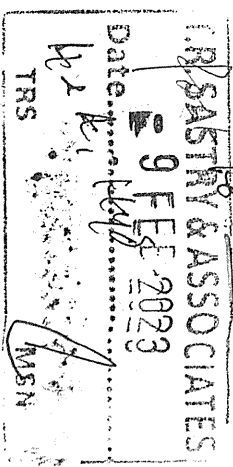

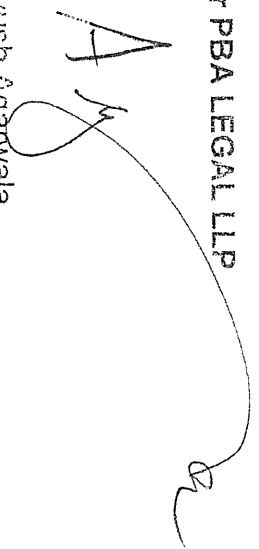
