Sri Satish Modi, aged about 39 years, hereinafter referred to as the Builder (which term shall mean and include its successors in office, administrators, executors / nominees / assignees, etc.)

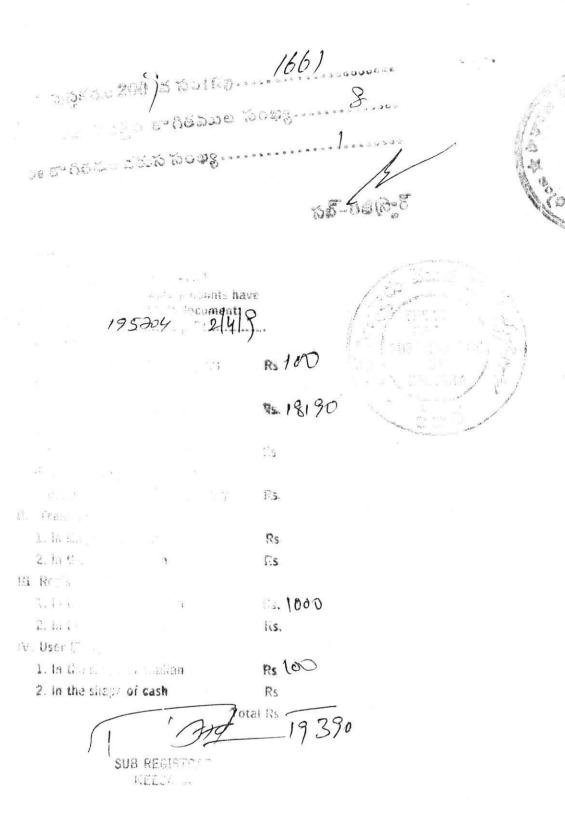
1. MRS. P. PADMA SAVITRI, WIFE OF MR. P. SAI KUMAR aged about 41 years, Occupation: Service

#### WHEREAS:

- The Buyer has entered into an Agreement of Sale dated 02.03.2009 for purchase A) of a house along with an identifiable plot of land (plot no. 53) in the project known as Nilgiri Homes, situated at Sy. No. 128, 129, 132, 133, 134, 135 & 136 situated at Rampally Village, Keesara Mandal, Ranga Reddy District. As per the terms and conditions of the said agreement of sale, the Buyer has agreed to pay development charges on land to the Builder at the time of registration of the Sale Deed, along with the consideration mentioned in the sale deed.
- The Buyer has purchased plot of land bearing plot no. 53 admeasuring 240 sq. B) yds. under a Sale Deed dated 02.04.2009 registered as document no. 16 Ex/19 in the Office of the Sub-Registrar, Keesara, R. R. District.,. This Sale Deed was executed subject to the condition that the Buyer shall pay the development charges on land for the development of land by laying of roads, drainage lines, electrical lines, water lines, development of parks and other developments as per the rules of HUDA.
- The parties hereto after discussions and negotiations have reached into certain C) understandings, terms and conditions etc., for the payment of development charges and are desirous of recording the same into writing.

#### NOW THEREFORE THIS AGREEMENT WITNESSETH AS UNDER:

- The Buyer has agreed to pay a sum of Rs. 18,29,000/- (Rupees Eighteen Lakhs 1. Twenty Nine Thousand Only) as the development charges to the Builder for development of the layout into plots by laying of roads, drainage lines, electrical lines, water lines etc., as per the rules of HUDA.
- The Buyer shall pay to the Builder the development charges of Rs. 18,29,000/-2. (Rupees Eighteen Lakhs Twenty Nine Thousand Only) in the following manner:

- The Buyer at his discretion and cost may avail housing loan from Bank / Financial 6. Institutions. The Buyer shall endeavour to obtain necessary loan sanctioned within 30 days from the date of provisional booking. The Builder shall under no circumstances be held responsible for non-sanction of the loan to the Buyer for whatsoever reason. The payment of installments to the Builder by the Buyer shall not be linked with housing loan availed / to be availed by the Buyer.
- Wherever the Buyer is a female, the expressions 'He, Him, Himself, His' 7. occurring in this agreement in relation to the Buyer shall be read and construed as 'She, Her, Herself'. These expressions shall also be modified and read suitably wherever the Buyer is a Firm, Joint Stock Company or any Corporate Body.
- In the event of any changes in the terms and conditions contained herein, the same 8. shall be reduced to writing and shall be signed by all the parties.
