



It has been decided that election for the office bearers shall now be held on 19<sup>th</sup> March 2023. Nomination forms are available with Mr. Sanjay, who shall be the Returning officer. Last date for filing of nomination forms along with required documents shall be 15<sup>th</sup> March 2023. Only those members who have Tenancy deeds for shop/office in their name and having no dues of maintenance charges shall be eligible for contesting the elections. Withdrawal of nomination can be made before 17<sup>th</sup> March 2023. Mr. Sanjay shall conduct the elections by secret ballot.

Only members having Tenancy deeds for a shop/office in their name and not having any dues of maintenance charges shall be eligible to vote. Ballot papers shall be given only to those members who are eligible to vote. One ballot paper shall be given for every 100sft of shop/office area as given in the Tenancy deed.

Please note that elections are being held for the period 1<sup>st</sup> April 2023 to 31<sup>st</sup> March, 2025 for 7 executive committee members. The Executive committee from amongst itself elect a President, Secretary and Treasurer.
