Reasons for Missing/Lost

This is to certify that on 01-01-2022 received a petition from Staramanjaneyulu Burri S/o: Koteshwara Rao Burri, Age: 54 years, Occ: Business, R/o: H.No. 6-107/1, Sri Venkateshwara Colony, Injapur, Hayathnagar, Hyderabad, in which he stated that he is the authorised representative of G.V. Discovery Centers Pvt. Ltd Office situated at 5-4-187/3&4, 2nd Floor, Soham Mansion, Ranigunj, Secunderabad has purchased the land extent Acre 2.25 in Sy.No. 234 & 235 situated at Turkapally Village, Shamirpet Mandal vide Registered Document bearing No. 8283/2018 from Tata Chemicals Ltd in turn he purchased the land from Shapoorji Pallonji Biotech Park Pvt Ltd by way of Sale Deed Document No. 4344/2005 registered at SRO Shamirpet and further Tata Chemicals Ltd had handed over the Original Sale Deed bearing No. 4344/2005 to G.V. Discovery Centers Pvt. Ltd in 2018. Further, he submitted that in the month of October 2021 they shifted their office G.V. Discovery Centers Pvt. Ltd from 2nd Floor to 3rd Floor during which they lost their Original Sale Deed Documents vide No. 4344/2005. He searched all over his office premises for Original Sale Deed documents at all possible places but could not trace it, so he lodged a meeseva petition at PS Ramgopalpet. He published an advertisement of missing his Sale Deed documents and also submitted an affidavit stating that the facts mentioned in the petition are true and correct.

In this regard out of STSTS. Lakshman caused enquiries at all levels and also verified his credentials in enterprise search application as a found no remarks. Further collected a True Copy from SRO, Shamirpet wherein the facts SHIGA SAT ULU collected is found a so obtained the witness statements of two members at the spot and made sincere 16:09-49 CMT-efforts to trace the above Original Sale Deed documents but could not trace it. Hence Certified.

On receipt of the complaint efforts were made to trace out the missing , but could not be traced.


