WHEREAS:

- A) The Buyer has entered into an Agreement of Sale dated 24th June 2008 for purchase of a house along with an identifiable plot of land (plot no. 87) in the project known as Nilgiri Homes, situated at Sy. No. 128, 129, 132, 133, 134, 135 & 136 situated at Rampally Village, Keesara Mandal, Ranga Reddy District. 1. The Buyer has agreed to pay a sum of Rs. 7,60,500/- (Rupees Seven Lakhs Sixty Thousand and Five Hundred Only) as the development charges to the Builder for development of the layout into plots by laying of roads, drainage lines, electrical lines, water lines etc., as per the rules of HUDA.
2. The Buyer shall pay to the Builder the above said amount for development charges of 7,60,500/- (Rupees Seven Lakhs Sixty Thousand and Five Hundred Only) on or before 15th November 2008
3. The Buyer shall liable to pay the development charges on land irrespective of the stage of development of the layout. The Buyer shall pay the amount as stated above and shall not raise any objection on this count.
4. That the Buyer shall be liable to pay simple interest calculated @ 1.5% per month on all delayed payments of installments. Under no circumstances shall the Buyer delay the payment of installments for more than 1 month from the due date.
