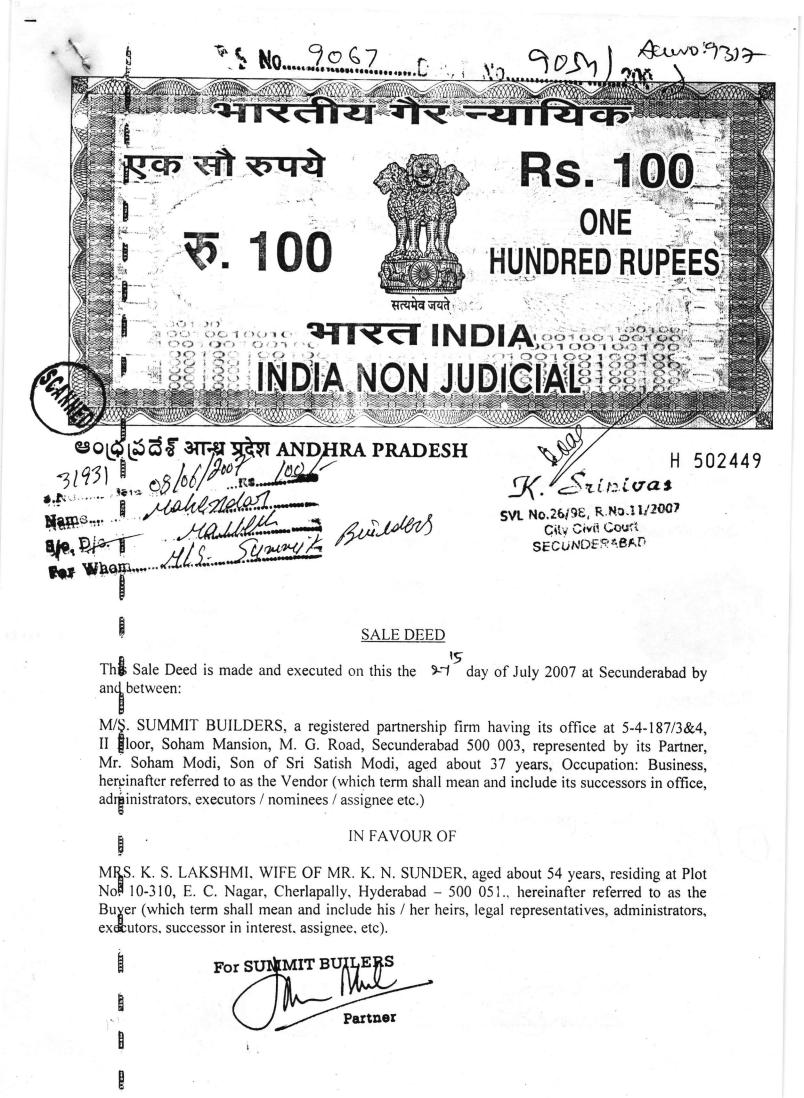

NOW THEREFORE THIS SALE DEED WITNESSETH AS FOLOWS:

1.
