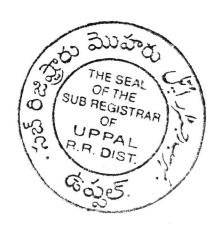

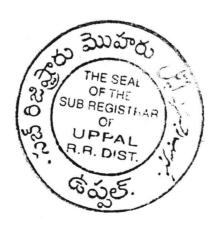

- 8. 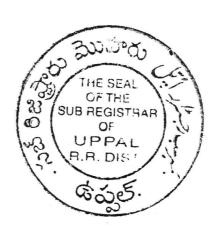
