NATURE OF BOOKING :

- 1.1 This is a provisional booking for a Flat mentioned overleaf in the project known as Silver Oak Apartments.
- 1.2 The provisional booking do not convey in favour of purchaser any, right, title or interest of whatsoever nature unless and until required documents such as Sale Agreement / Sale Deed / Work Order etc., are executed.
- The purchaser shall execute the required documents within a period 30 days from this booking along with payment of the 1st installment mentioned overleaf. In case, the purchaser fails to do so then this provisional booking shall stand cancelled and the builder shall be entitled to deduct cancellation charges as mentioned herein below.

REGISTRATION CHARGES: 2.

Registration Charges, Stamp Duty and incidental expenses thereto as applicable at the time of registration shall be extra and is to be borne by the purchaser.

3. , MODE OF PAYMENT :

3.1 All payments from outstation locations are to be paid through DEMAND DRAFTS only. Demad Drafts / Local Cheques are to be made payable to M/s.SUMMIT BUILDERS.
