#### WITNESSETH

The HIREE has obtained on lease vide Lease Agreement dated 02<sup>nd</sup> day of March, 2023 bearing registered lease deed document no. **722** of 2023, registered at Sub-Registrar Office, Secunderabad for the office space situated on the II floor of the building known as Soham Mansion, bearing No. 5-4-187/3 and 4, situated at M.G. Road, Secunderabad – 500003, having a super built area about 3,000 sft, from the OWNER. At the request of the HIREE, the owner has agreed to provide amenities to the HIREE more fully described in the schedule. The HIREE has agreed to pay amenities charges for the said amenities apart from the rent payable to the OWNER.

## NOW THIS DEED WITNESSETH AS UNDER

- 1. The HIREE shall pay amenities charges of Rs.32,196/- (Rupees Thirty Two Thousand One Hundred and Ninety Six Only) per month apart from and along with the rent payable, subject to the clause pertaining to the enhancement of the amenities charges given hereunder.
- 2. The lease shall be for a period of ten years commencing from 01st day of March, 2023.
- 3. The HIREE shall enhance the amenities charges by 6% at the end of every year on the then existing amenities charges.
- 4. The HIREE shall pay the amenities charges for each month on or before the 7<sup>th</sup> day of the month to the OWNER.
- 5. The HIREE shall not be entitled to surrender the usage of amenities as long as the tenancy is subsisting.
- 6. Any default in the payment of amenities charges shall be deemed to be a breach of the convenants of tenancy and the OWNER shall be entitled to determine the lease and the HIREE shall give vacant possession of the tenancy.
- 7. The HIREE shall pay monthly maintenance charges amounting to Rs. 2/- (Rupees two only) per month to the OWNER or M/s. Soham Mansion Owners Association or to any other party that the owner may direct, towards the maintenance of common areas, common area security, water charges, etc. subject to increase from time to time.
- 8. The OWNER and the HIREE hereby undertake to register this agreement as and when called upon by either of the parties at any time during the currency of this agreement. The expenses of stamp duty and registration charges of this agreement in duplicate and all other incidental expenses shall be borne by the HIREE in full.
- The HIREE shall be liable to pay all taxes, levies, charges like GST, etc., that are payable or shall become payable to any government or statutorily authority from time to time pertaining to amenities charges and other charges payable under this agreement.


