- The Government, after careful consideration of the proposal, hereby order the following rates of premium and quit rent and the grant of period of lease and other matters in respect of plot of land in the Azamabad Industrial Area, Hyderabad, under the said Act and the Rules made thereunder:
  - (a) A premium of Rs.500/- (Rupees Five hundred) per square yard in all the cases;
  - (b) Quit Rent at 10 (ten) paise per square yard per month, subject to revision by such amount at the end of ten years;
  - (c) The period of lease shall be 25 (twenty five) years and if the Lessee makes an application for renewal of lease, the Competent Authority shall renew the lease in accordance with the terms and conditions prescribed under the Fules; and

(d) The lease shall be further subject to the condition that the Lessee will use the land for the purpose for which it was leased out and shall abide by all other terms and conditions including timely payment of premium and quit rent.
