Sub: Allotment of Cement - Reg.

AA :: ::

We and our three other sister concerns are engaged in manufacture of deep well hand pumps. The pumps are in great demand. Quality pumps are in short supply. To meet the demand by quickly increasing the production, we had approached our neighbour Shri. Laxmilal Pitti, who was the then lessee of the industries department to give us his consent for transfer of lease in our favour. He had readily obliged. We had then made a formal application to your department for affecting the transfer of lease. To avoid delay we alongwith our sister concern jointly/collectively prepared factory proposal, and submitted to the Municipal Corporation, for approval. The then lessee Shri. Laxmilal Pitti, realising the need had agreed to give us authority to apply for municipal approval in his name. The Industries department was kind enough to consider our request and accord transfer of lease before the municipal sanction was granted to us. The fact of the division of premises and allotment of the same to the four units was conveyed to MCH by industries department. They had also requested to withhold the permission, pending Industries departments approval to the proposed collective construction. We had then submitted the copy of the Municipal plans to the industries department and also gave necessary undertaking required by the Industries Department. The Industries Department was kind enough to approve our collective proposals and conveyed their approval to Municipal Corporation. Consequently, we have received the approval for the same from M.C.H.

It is pertinent to say that despite best of our efforts, due to the procedural requirement and circumstances and beyond our control, we had lost nearly two years. Ours is small scale units, we are eligible for getting the levy cement. Cement applications of each of our unit were scrutinised and forwarded with the necessary recommendation, for the allotment of cement, by Regional Development Officer, twin city circle office, Musheerabad, Hyderabad.

We now understand that we are required to obtain fresh Municipal permission in the individual units name. We beg to state that the permission were collectively applied by us and approval was obtained for construction on a particular site. We are putting up

constructions as per the approval, on the site for which the approval is granted. The Municipal permissions are given for particular site and area in accordance with the Municipal bye-laws and zoning regulations only and it does not pertain to any individual or unit. Hence we request you to consider the following fact, and allot us the required cement and oblige.

1. The units concern is a S.S.I., registered small scale unit, engaged in drought affected programme for drinking water and also actively promoting exports of the pumps.
2. The collective sanction was obtained by us to expeditiously meet the requirement of quality pumps.
3. The fact of collective applications was done with proper authority and with the knowledge and consent of both the industries department and also the Municipal Corporation.
4. The requirements are immediate and genuine.
5. It is extremely difficult, both cost and time wise, to obtain fresh Municipal sanction in individual units name.

We trust considering the above facts our requirement ^{if consent} to the maximum extent, will be granted from out of the levy cements.
