We have to report for your information that you had received our letter No. 47/2009 dated 28-10-52 on the 13th of March 1953 in which you had mentioned that you are preparing for the line of additional load and you would let us know very shortly.

Since then we had acknowledged the same letter on 27-3-53. We are very sorry to say that we have not received any reply in that connection.

We had also an interview with the Transmission Engineer personally 2 or 3 times, who also consoled us that he would send the estimation in near future.

We request both of you that as you know that this matter is still pending since last 2 1/2 Years, and now we have lost our patience, we request you to remove the time switch and arrange to allot us the Day power at your very earliest convenience for which we shall thank you in anticipation. We had also drawn your kind attention that we have got 10 max colours in this Paint line and the same is not found satisfactorily during Night time so we request you to pay your immediate attention.

Dear Sirs,

We have to acknowledge the receipt of your letter No. 2987 dated the 14th instant and have noted the contents with many thanks.

With reference to the same we have to inform you that you inform us that you will give us day power load after 2½ years passed with your scheme.

According to your new scheme you have mentioned in your letter that we should pay Rs. 266/- every month whether we may use the energy or not, for the period of 4 Years and to deposit Rs. 1136/- with you which will be refunded after the period of 4 Years.

Owing to the general depression of the Trade, we have to inform you that a small concern like us will not bear such exorbitant very costly scheme. If you would have informed us regarding this scheme in the commencement, we would have given due consideration at that time, because for having no electric power during day time and as we could not fulfil our customers' works in time, consequently, our Financial Partner was quite disgusted, and he severed all his connections with us and deserted us.

We had requested you many a times for day Power, but we are very sorry to say that your Electric Power Department did not give their cooperation to our Industry, and by that we were compelled to almost stop our business as day power was not obtained without any extra expenses.

We request you again that the load in our line is reduced to some certain extent, and we request you to test the line again, and allow us to work for 2 or 3 days in day time and if you find any difficulty in the line then we will stop the same.

If you will please agree to our above suggestion i.e. you allow us to work for 2 or 3 days under the personal supervision of your staff, then we will not be satisfied.

So we earnestly request you to make this experiment by taking kindly view toward us for the sake of GCD.

We hope you will please peruse this letter carefully, and please inform us our request, for which we shall thank you in anticipation.

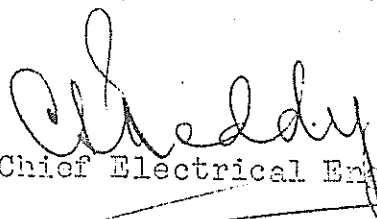

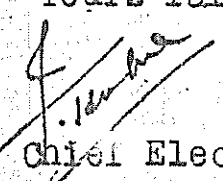
