Your attention is invited to Section 452 (2) of the Hyderabad Municipal Corporations Act,
1955 and if you fail to show cause in the manner required above or to alter or amend the building or work
mentioned above the fact reported to the Commissioner or any other officer authorised by him in this
behalf, within stipulated time the said building or such portion / portions of the building or work or such
portion / portions of the work as is found contrary to the sanctioned plan shall be removed / altered or
amended / pulled down or cause to be removed / altered / amended / pulled down by the Commissioner, on
the presumption that you have no cause to show or no explanation to offer and the expenses thereof shall
be recovered from you.
